- 1. The RFB didn't mention irrigation. Is irrigation to be included or just lawn maintenance and fertilization?**

Answer: Only lawn maintenance and fertilization are needed at this time.

- 2. Is it possible to bid on a few of the locations or is it required to bid on all of them?**

Answer: Only vendors that bid on all locations will be considered.

- 3. Do you want a cost for shrub trimming and bed maintenance?**

Answer: No. Only lawn maintenance and fertilization are needed at this time.

- 4. Can we select the properties and choose what to bid on or do we have to bid in all of the properties??**

Answer: Only vendors that bid on all locations will be considered.

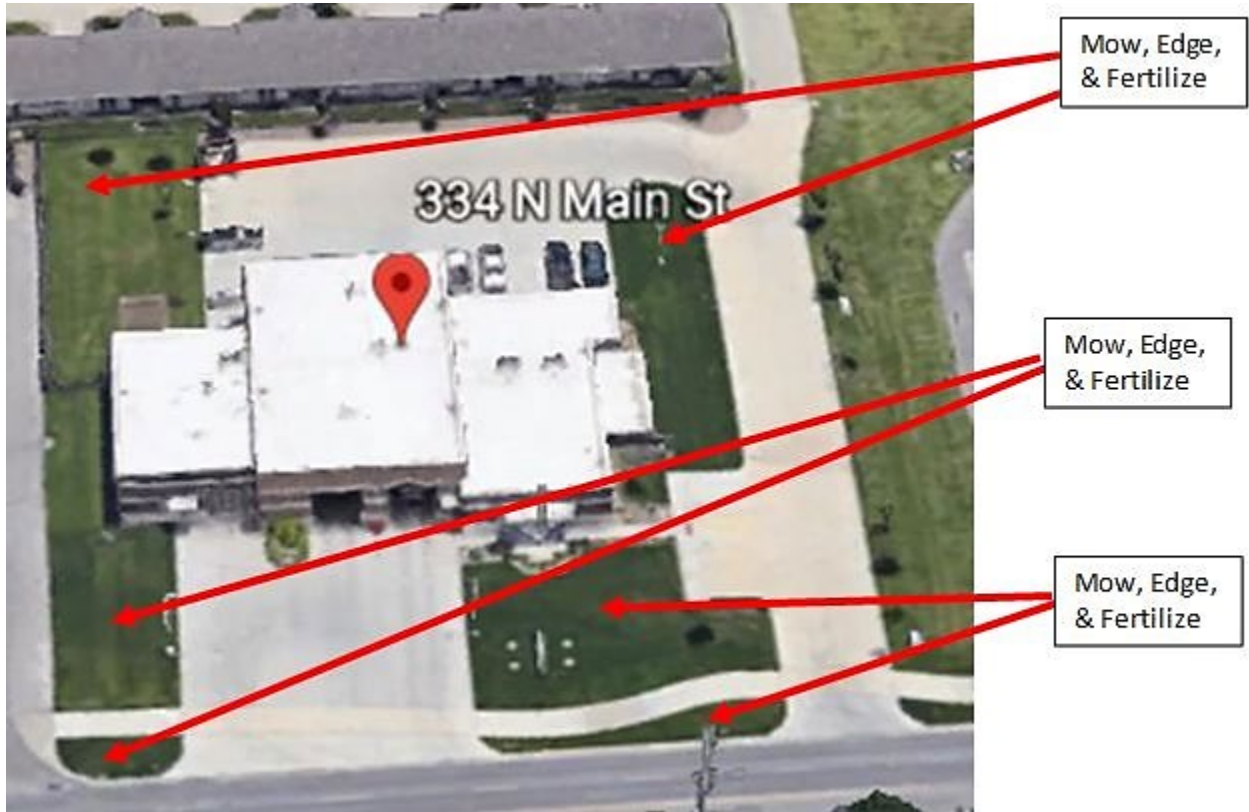

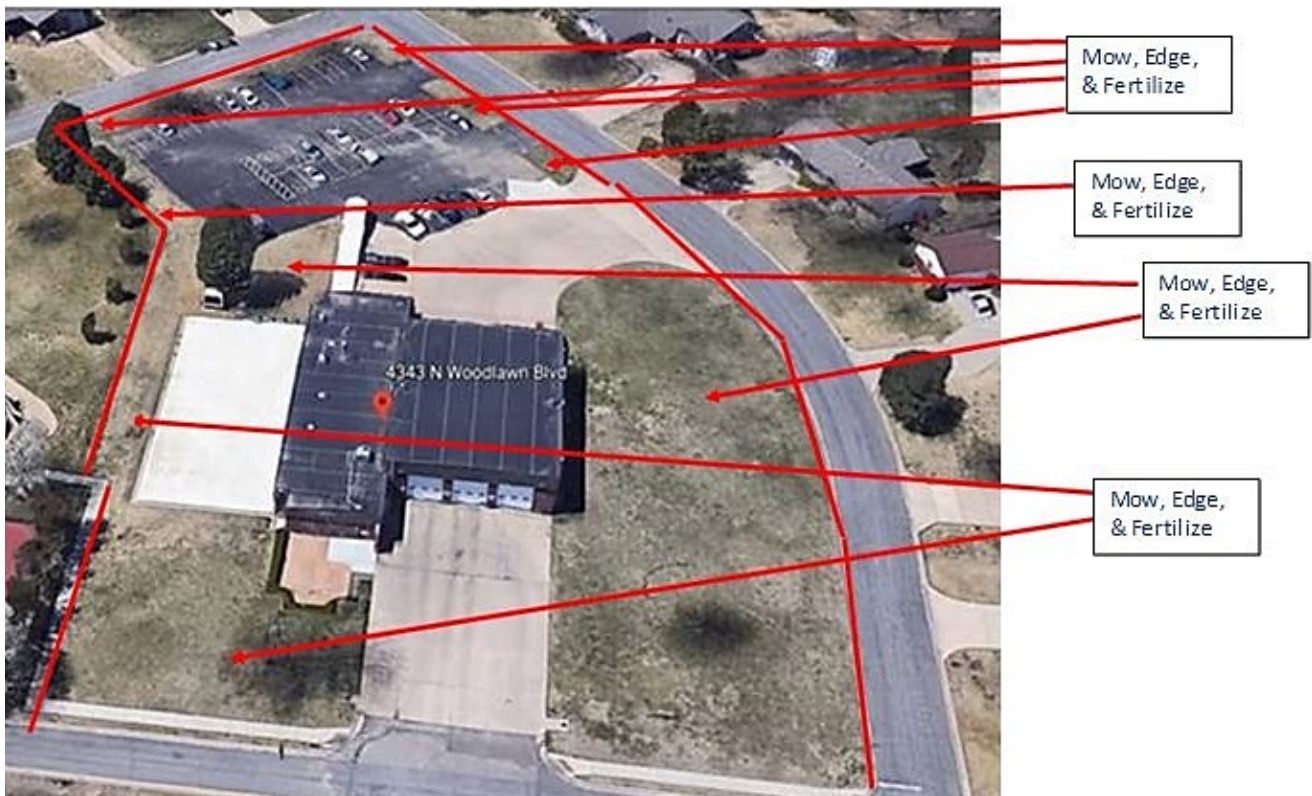


