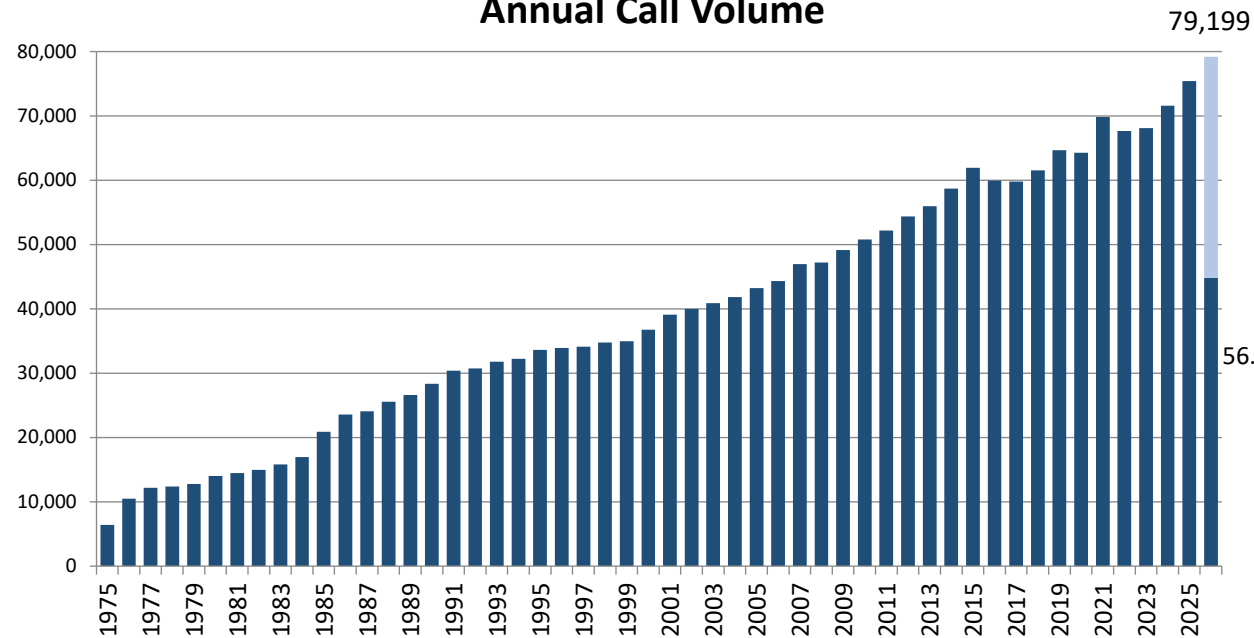

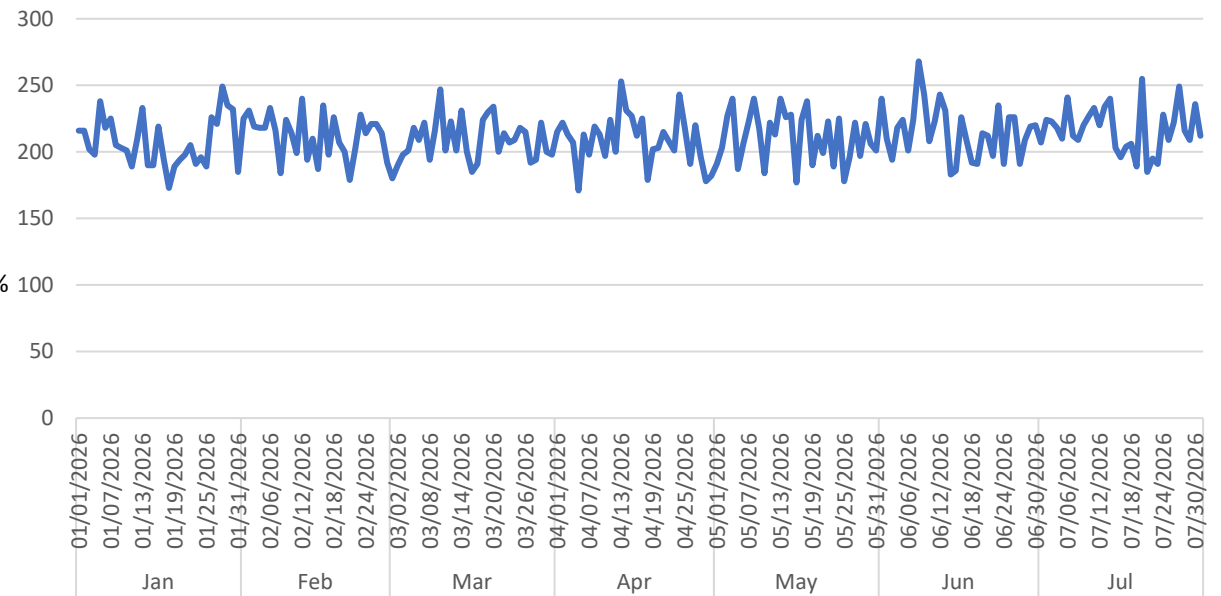

Call Volume & Response Time

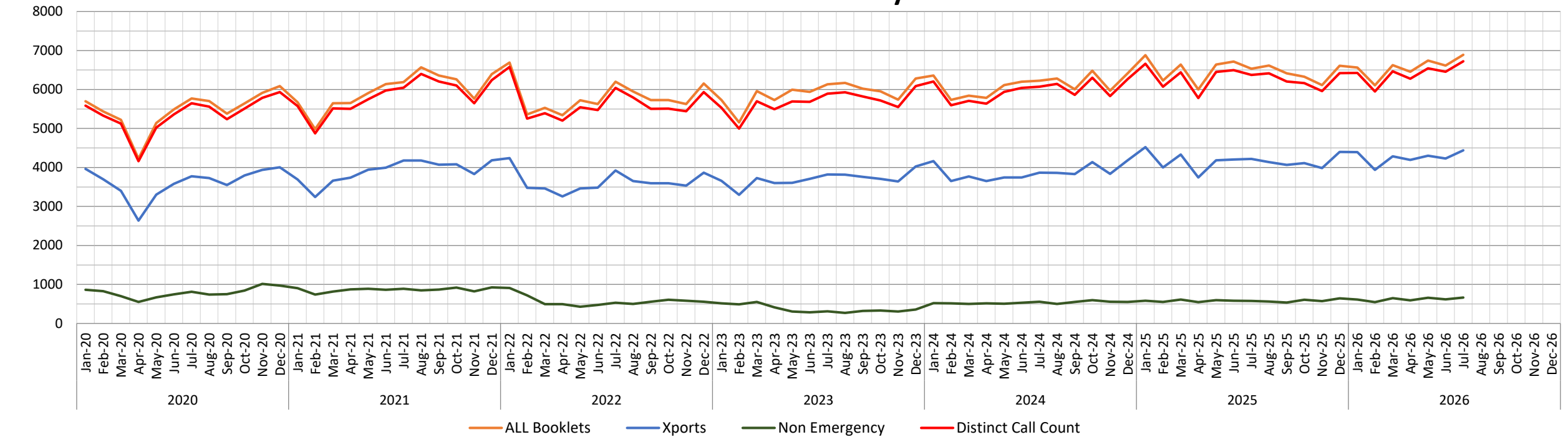
Annual Call Volume

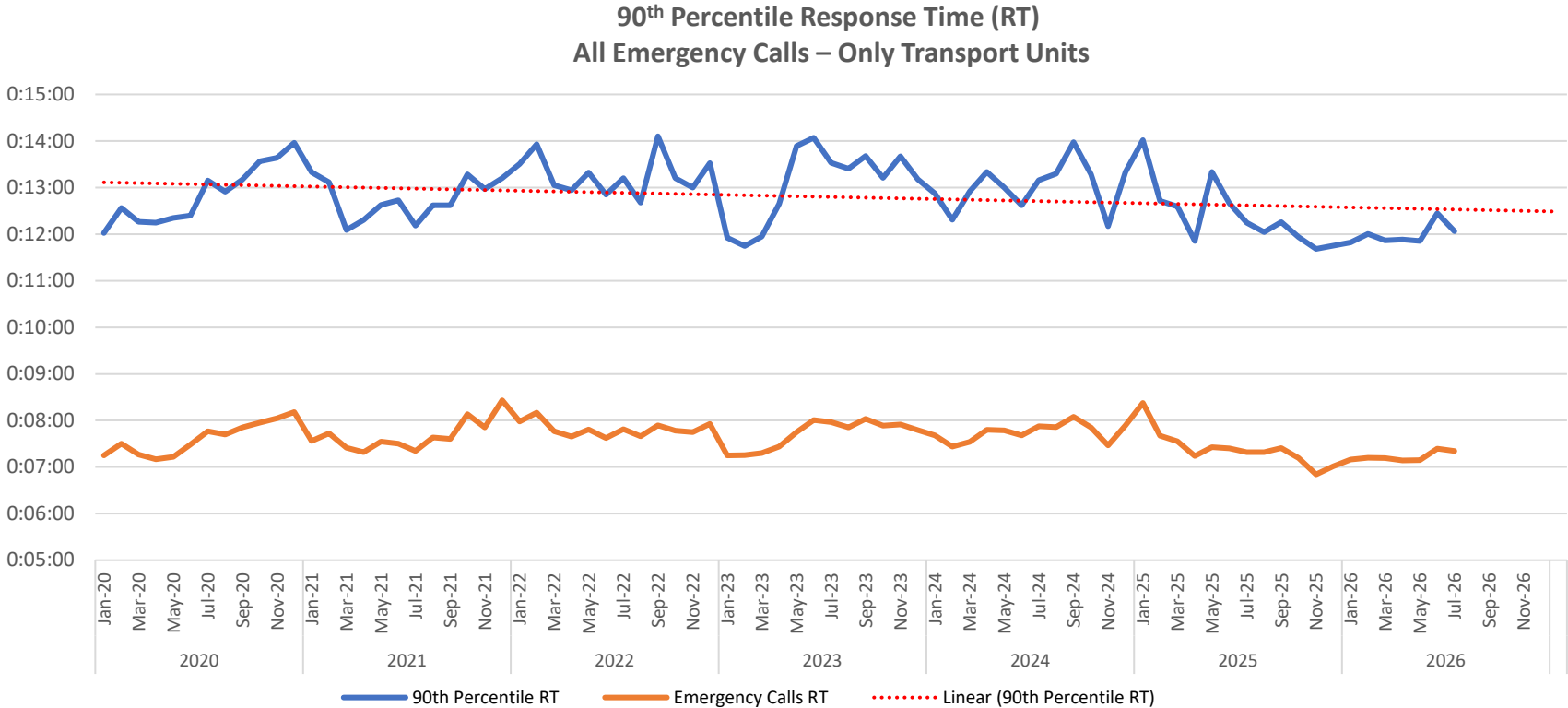

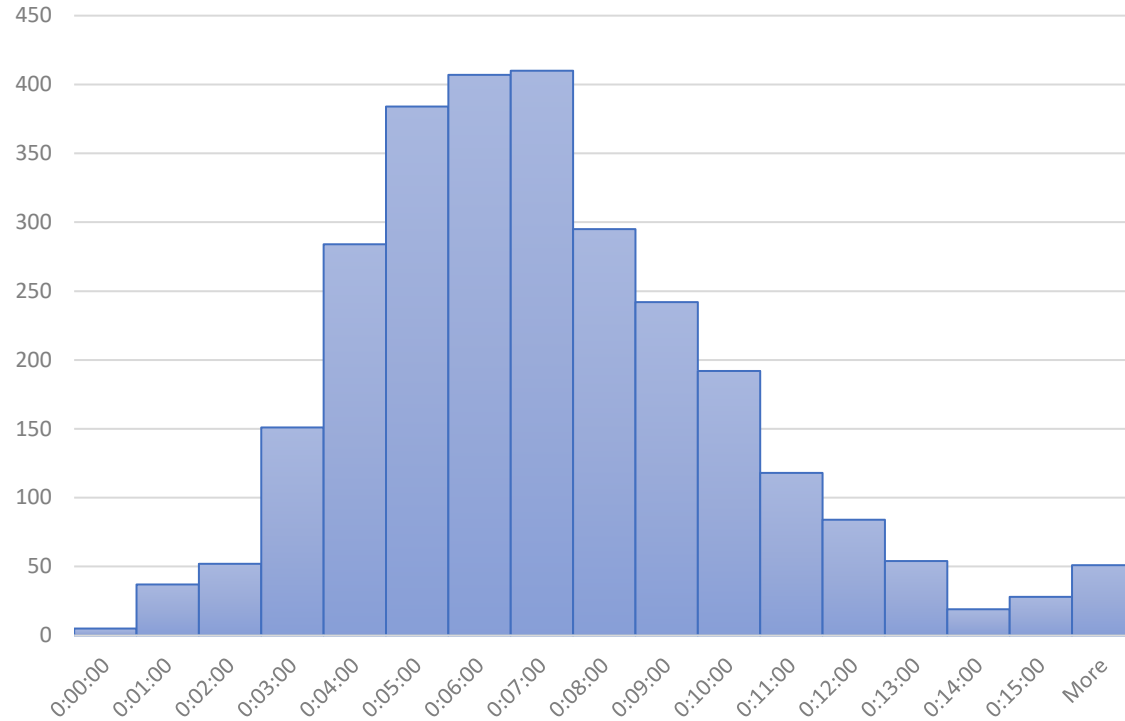

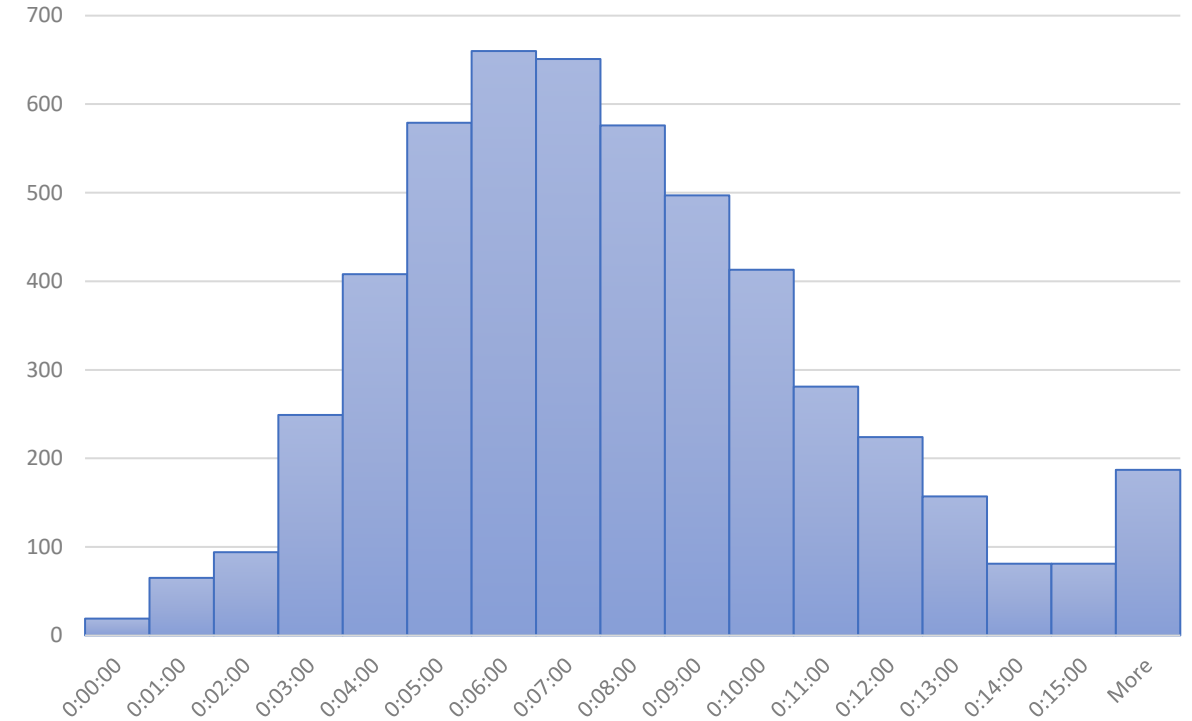

Response times (RT) are measured from dispatch to arrival on scene. EMS responds to calls using lights and sirens on Priority 1 and 2 emergency calls only, which was 54% of emergency calls in July.
